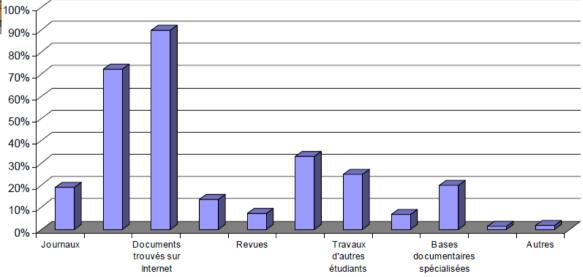

9 reports out of 10 (91,9%) contain at least one identical part copied from the internet. (2008)

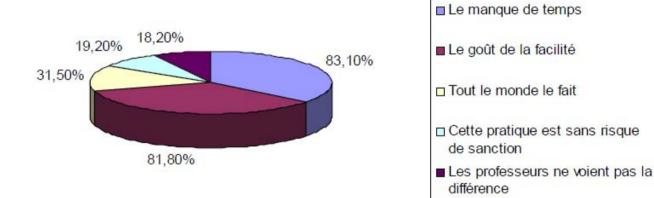

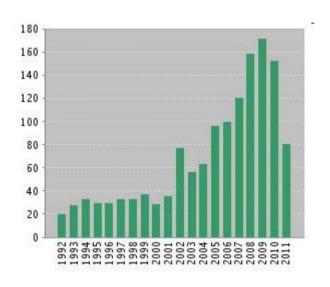

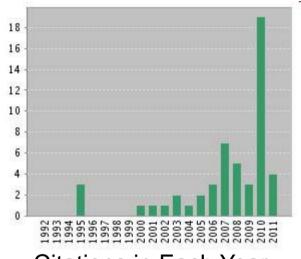

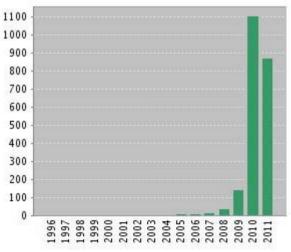

the meta-analysis. A pooled weighted average of 1.97% (N = 7, 95%CI: 0.86–4.45) of scientists admitted to have fabricated, falsified or modified data or results at least once –a serious form of misconduct by any standard– and up to 33.7% admitted other questionable research practices. In surveys asking about the behaviour of colleagues, admission rates were 14.12% (N = 12, 95% CI: 9.91–19.72) for falsification, and up to 72% for other questionable research practices. Meta-regression showed that self reports surveys, surveys using the words "falsification" or "fabrication", and mailed surveys yielded lower percentages of misconduct. When these factors were controlled for, misconduct was reported more frequently by medical/pharmacological researchers than others. Considering that these surveys ask sensitive questions and have other limitations, it appears likely that this is a conservative estimate of the true prevalence of scientific misconduct.

How Do Editors and Publishers React to Plagiarism?

- 3. "There has been a paucity of literature examining the reactions of stakeholders (both victims and perpetrators) when confronted with evidence of possible misconduct."
- 4. "22% were from coauthors claiming no involvement in the writing of the manuscript. An additional 17% claimed they were unaware that their names appeared on the article in question."
- 5. Retractions « do not propagate back to MEDLINE » and « researchers and clinicians may never become aware of an article's retracted status »

Does it Really Matter?

- 6. "A large portion of the duplicates were published in **low- profile journals**."
- 7. "we found that **original** publications were cited **28 times** on average, whereas their corresponding **duplicates** were cited only **twice**."

BUT "the duplicate article was cited at least as often as the original publication"

How Do Editors and Publishers Respond to Plagiarism?

- 8. « The majority of these **editors** showed **deep concern** and were open to any helpful suggestions or recommendations».
- Some apparently do not want to deal with the added stress of conducting a thorough investigation."
- 10. "journal editors, many of whom are distinguished scientists themselves, **must** not merely trust in,

but also verify the originality of the manuscripts they publish"

A Big Cleaning is Needed, but...

Keep it clean

Integrity guidelines are a good start, but they must be clear and appropriately enforced.

aintaining integrity in science seems to be in fashion. US officials are preparing to review policies on scientific integrity drafted by some 19 government agencies. Canada is overhauling its research-integrity policy, and the UK Research Integrity Office is looking for new sources of support after losing government funding. The European Commission has also started to discuss how to include scientific integrity in its research framework agreements.

The US policies will apply not only to agency scientists, but also to political appointees, managers and public-affairs officials. This broad scope is deliberate and intended to avoid a repeat of the alleged abuses of science that occurred under the administration of former US President George W. Bush (see page 262).

Still, to frame such policies so broadly does bring potential trouble — how should officials apply them to scientists? Vague requirements, such as to approach research objectively and to welcome constructive criticism, are good professional codes of conduct — but they must not be interpreted as a stick with which politically conscious managers can beat scientists to suppress inconvenient scientific findings.

It would be too easy for officials to violate the intended spirit of a loosely worded scientific-integrity policy by claiming that scientists had violated the letter of it. The United States classifies scientific misconduct as falsification, fabrication or plagiarism, and the broad concept of integrity must be coordinated carefully with that narrow definition. And, of course, good policies are not enough if they are not implemented wisely. To that end, US federal agencies must continue to improve their practices through training for managers of scientific staff, and ensure that they turn to the proper scientific expertise when misconduct is alleged.

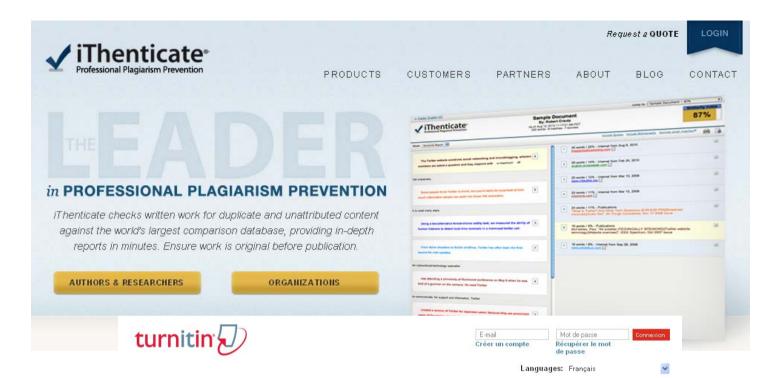

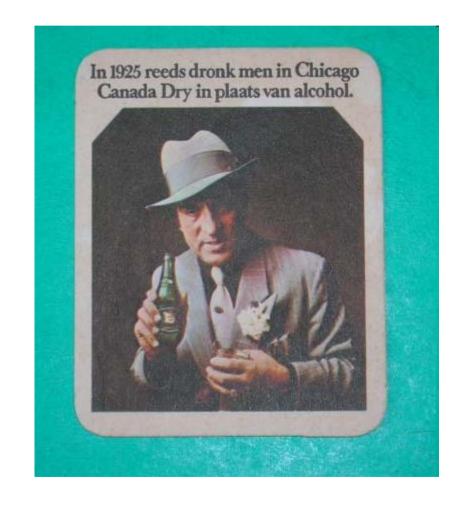

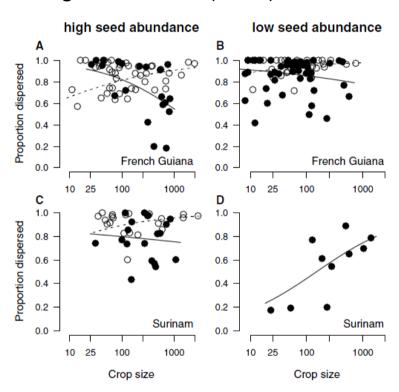


Figure 2. Proportion of seeds dispersed as a function of crop size for C. procera trees in bunted areas (filled circles, solid lines) and protected areas (open circles, broken lines) in years of bigb (a and c) and low fruit abundance (b and d). Circles represent the

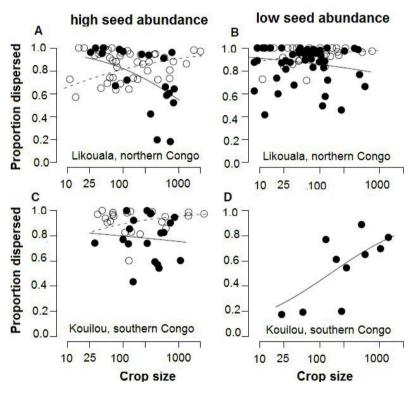


Figure 2. Proportion of seeds dispersed as a function of crop size for *B. toxisperma* trees in hunted areas (filled circles, solid lines) and protected areas (open circles, broken lines) in years of high (a and c) and low fruit abundance (b and d). [...]

Plagiarism leads to seven retractions (and counting) in the conservation literature

with 18 comments

An ecology researcher in the Congo has found himself at the center of a plagiarism scandal that has felled seven of his papers.

As <u>Science reports today</u>, <u>Serge Valentin Pangou's</u> work began unraveling in August 2011 after Wageningen University ecologist <u>Patrick Jansen</u> thought a paper he'd been asked to review for the *International Journal of Biodiversity and Conservation* seemed familiar — because he'd written many of the same words in a 2007 paper in *Conservation Biology*. He ran the manuscript through the plagiarism detection software Turnitin, and sure enough, it was about 90% identical.

Unfortunately for Pangou, Jansen's co-author on the *Conservation Biology* paper was <u>Pierre-Michel Forget</u>, whose father, as *Science* notes, "was a well-known private detective in France." Forget and Jansen took a careful look at a number of Pangou's papers,

concluding that at least nine of them, published between 2006 and 2011, were plagiarized in whole or in part. An investigation by *Science* supports Forget's conclusions and also finds that some of Pangou's co-authors were unaware that their names were used.

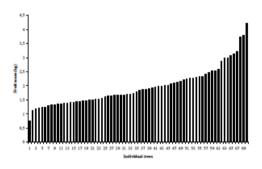


Figure 2.3. Tree-to-tree variation in fruit mass in *Allambiackia floribunda* from wild stand in Cameroon.

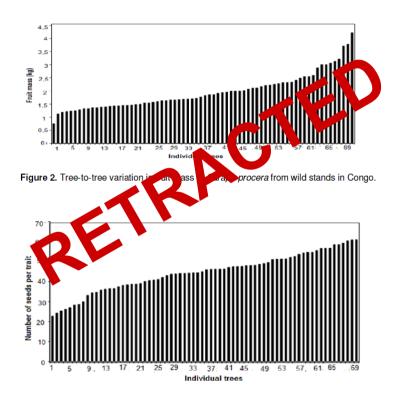


Figure 3. Tree-to-tree variation in seed number per fruit in Carapa procera from wild stands in Congo.

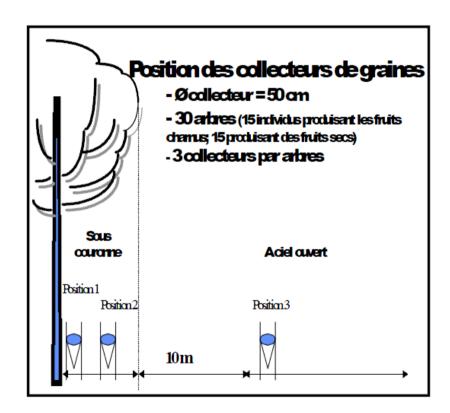

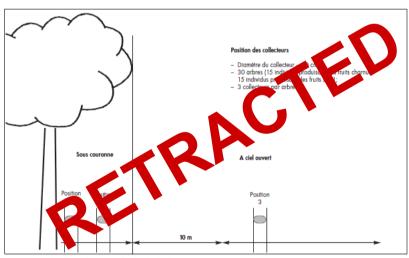


Fig. 1. – Disposition des collecteurs de graines sous les arbres dans les champs

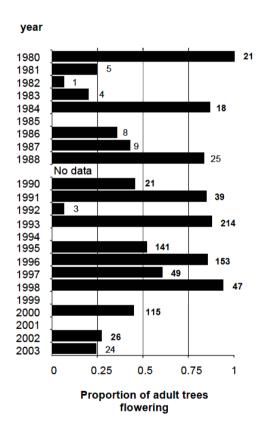


Figure 2A.2. Variation in population flowering effort of *D. guianensis* over 24 years in the vicinity of Paracou, French Guiana. The size of population sample monitored differ among year with a minimum of 21 individuals (see Table 2A.1). The number of flowering individuals is indicated at the end of each bar.

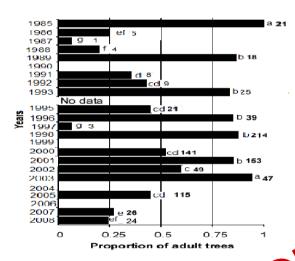


Figure 2. Variation in population flowering effort of *Pterocarpus soya* and early the vicinity of Dimonika at Mayombe rain forest in Congo. The size of population is inple monitored differs among year with a minimum of 21 individuals (see Table 1). The number of flower in vindividuals is indicated at the end of each bar. Proportions followed by the same letters are not as different (Mann-Whitney test, P values < 0.01).

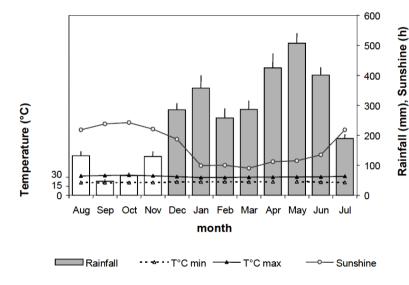


Figure 2A.1. Annual climate pattern at Paracou, French Guiana $(5^{\circ}15'N; 52^{\circ}55'W)$ over 1979-2002. Average total annual rainfall is 3081 ± SE 143 mm (N = 24 years). Monthly climate data are as follows: mean (+SD) rainfall for 1979-2002; mean number of sunshine hours for 1989-1991; mean maximum and mean minimum temperature for 1995-2002 (see Table 2A.2 for sources). Open bars are dry-season months.

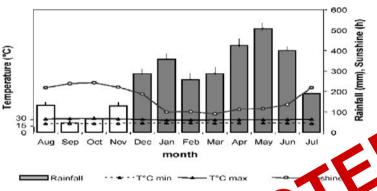


Figure 1. Annual climate pattern of Dimonika (12º26E; 4º12'S) at Mayombes are prest in longo, over 1984-2007. Average total annual rainfall is 3081 ± SE 143 mm (N = 24 years). Monthly climar data are as follon; mean (+SD) rainfall for 1979-2002; mean number of sunshine hours for 1994-1996; mean maximum and mean minimum temperature for 2000-2007 (see Table 2 for sources). Open bars are dry-season months.

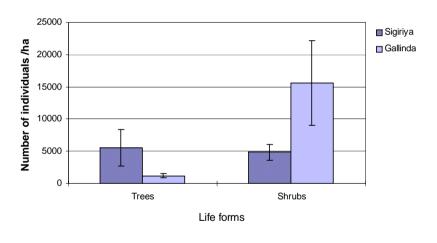


Figure 1. Density of tree and shrub species at Sigiriya and Gallinda high forests with 95% confidence limits:

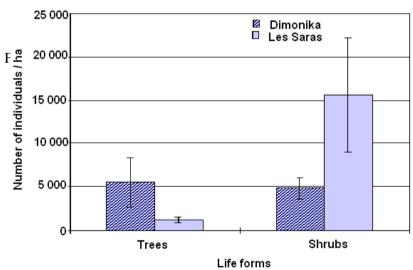


Figure 2. Density of tree and shrub species at Dimonika and Les Saras high forests with 95% confidence limits.

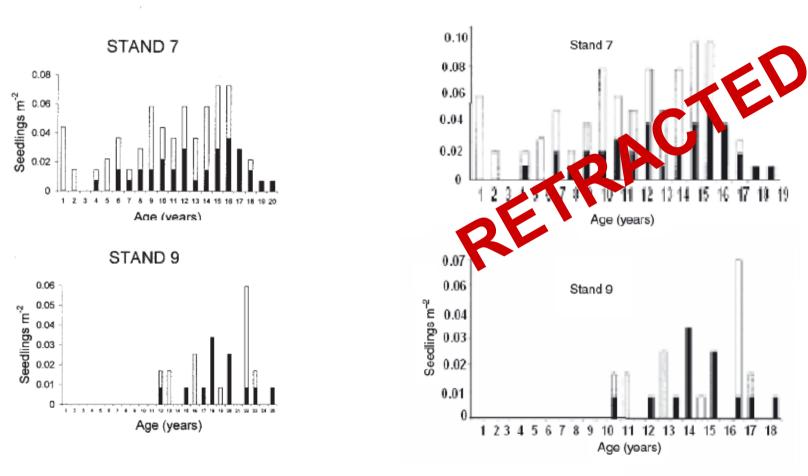
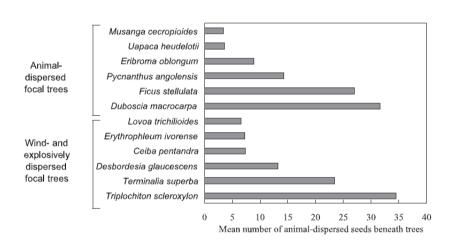


Figure 2. Age structure of 11 natural regenerated stands in the High Ebro Basin (Northern Spain). White bars indicate suppressed or injured seedlings.

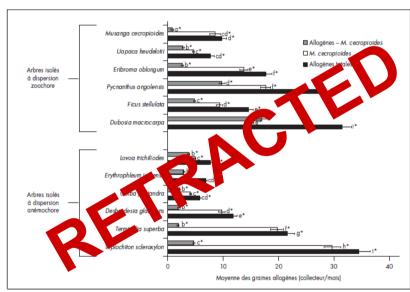


Fig. 5. – Nombre moyen total de graines allogènes par espèce d'arbre isolé. Il est présenté : le nombre total de graines allogènes ; le nombre de graines des outres espèces. Les valeurs (moyenne + erreur standard) sulvies de la même lettre ne sont pas significativement différentes (* – P < 0,05).

Reviewer's Déjà Vu, French Science Sleuthing Uncover Plagiarized Papers

Michael Balter

An investigation by a French ecologist into papers authored by Serge Valentin Pangou, director of the Study and Research Group on Biological Diversity in the Republic of the Congo, concluded that at least nine contained material plagiarized from other researchers' work. An investigation by *Science* also found that some of Pangou's co-authors were unaware that their names were used. The affair has already led to the retraction of four papers on which Pangou is the corresponding author, as well as the rejection of a paper submitted to the *International Journal of Biodiversity and Conservation*. Pangou tells *Science* that he accepts "all of the responsibility" for the papers that have already been withdrawn, but he contends that he did not deliberately engage in plagiarism, chalking it up to "the abusive utilization of bibliograph[ies]" which he "regrets sincerely." He did, however, admit to *Science* that he added some authors to papers without their knowledge.

Predatory Publishers and Plagiarism Prevention

M. BALTER ("REVIEWER'S DÉJÀ VU, FRENCH science sleuthing uncover plagiarized papers," News & Analysis, 9 March, p. 1157) describes how a scientist recently published at least nine articles that largely or entirely duplicated papers written by others and was exposed only after we found one of our papers integrally copied in a manuscript that both of us coincidentally received for review. What is remarkable here is not only the flagrant fraud, but the fact that six of these papers were published in scholarly journals only last year. Publishers can easily prevent publishing plagiarism by sys-



tematically running submitted manuscripts through software such as CrossCheck and eBlast (1, 2) or by running strings of words that are unlikely to be repeated by chance through search engines (3). It is evident that not all publishers systematically use these tools, despite the fact that plagiarism is common (1, 2). It is also noteworthy that these six 2011 papers—as well as the manuscript for review-are all from journals of publishers that Beall (4) lists as "predatory openaccess scholarly publishers." Such publishers "exploit the author-pays, Open-Access model for their own profit" and do not invest in quality control (4, 5). In this light, it is less surprising that papers escape plagiarism detection today. We argue that publishers that do not systematically use anti-plagiarism tools consciously take the risk of copyright infringement and of being accomplices in plagiarism. We encourage copyright holders to sue publishers of plagiarism for these offenses. When fines become a realistic threat, plagiarism prevention will become valuable even for predatory publishers.
